



Phase 1: Gap Assessment

1-2 Months

Connect & Determine Scope

- Team introductions
- Kickoff meeting
- Determine scope, including assessment criteria

Assess the Client

- Walkthroughs and interviews
- Document reviews
- System observation and inspection

Prepare & Finalize Deliverables

- Prioritized gaps and recommendations
- Initial set of controls
- High-level scope definition

Debrief

- Present deliverables to client
- Communicate Phase 2 budget



Phase 2: Remediation
